sigikid was founded almost 40 years and is today a family owned company in the 2nd generation. Early on, sigikid became known not only for its unique design and creative products, but also for its high quality standards, noticeable in the ultra softness and durability of our toys.

Up until the mid 90s we proudly manufactured everything in Germany. With the increasing globalization and expansion into new markets however, we - much like everybody else in the industry - gradually shifted operations to outside suppliers over the next decade.

Today, we are proud to confirm that sigikid adheres to the same safety and quality standards as when everything was still made in Germany. For our products we use only the best materials and are very careful in whom we allow to manufacture under the sigikid label. All our products are designed and produced with the same affection, diligence and attention to detail, no matter where they come from: Be it from our joint venture in Romania, or from our partners in Thailand, Indonesia, China and India.

Our product testing itself is divided into two stages - both of them equally important. We start our tests with parents and kindergartens until we are convinced that the toy playfully adds value to a child's rearing.

Compliance with the regulations of independent labs, e.g. the Technical Supervisory Association (TÜV), is the second stage of our product testing. All our products are tested according the European Safety Standard for toys, EN 71, and are certified accordingly.
